#### CASH, CHECK, OR CREDIT CARD GIFTS

You can choose to donate once or pledge multiple contributions over time, in an amount and schedule that suits you. Donations can be made via cash or credit card and set up for automatic withdrawal if desired.

#### ENDOWMENT GIFTS

Support the Grand Forks Children's Museum with an endowment of cash, securities, or marketable assets.

40% ND tax credit for endowments. Create a legacy with a qualified N.D. endowment and receive a 40% credit (up to \$10,000) for contributions from North Dakota businesses and individuals who donate \$5,000 or more. Couples filing jointly can receive up to \$20,000. in tax credit per year.

#### STOCK GIFTS

Donate appreciated securities to the Grand Forks Children's Museum, and you could qualify for a charitable income tax deduction based on the full market value, while avoiding capital gains tax.

#### IRA GIFTS

Donors aged 70½ or older can transfer up to \$100,000 tax-free annually from their IRA directly to the project. For more details, contact your IRA administrator.

#### TRIBUTE GIFTS

Donate to the Grand Forks Children's Museum and Destination Park in honor or memory of someone special. We will notify the honoree or their family.

#### MATCHING GIFTS

Double your donation through your employer or your spouse's employer if they offer a matching gift program. If you're employed by, retired from, or serve on the board of such a company, please submit their matching gift form to amplify your contribution.
